1.0 PRODUCT DESCRIPTION

Skin Cleanser is a gentle, pH balanced no-rinse cleanser, designed to leave the skin supple and hydrated and can be easily dispensed with one hand.

2.0 INTENDED PURPOSE

Skin Cleanser is intended for incontinence and general cleansing needs.

2.1 INTENDED POPULATION

The product may be used on adults and children.

2.2 INTENDED USERS

Intended for use by health professionals and caregivers and may be used in a hospital, community and home setting.

3.0 INDICATIONS

Skin Cleanser indicated for incontinence and general cleansing needs. It is designed to be gentle on raw or sensitive skin associated with incontinence.

4.0 CONTRAINDICATIONS

None Listed.

5.0 WARNINGS

For external use only. Avoid contact with eyes. If contact occurs, rinse eyes thoroughly with water. Consult a physician if the condition worsens or persists for 7 days. Skin Cleanser should not be used on individuals who are known to have allergic sensitivity to any ingredients listed. Keep out of reach of children.

6.0 DIRECTIONS FOR USE

To use as a spray: Toggle the spray nozzle to the spray mode by twisting the spray nozzle to the spray setting. Depress the trigger to generate spray.

To use as a stream: Toggle the spray nozzle to the stream mode by twisting the spray nozzle to the stream setting. Depress the trigger to generate stream.

The Skin Cleanser should be applied directly onto the soiled area or onto a warm washcloth. Wipe clean, pat dry (no rinsing required). Repeat when necessary.

INGREDIENTS

Purified Water, Sodium Laureth Sulphate, Glycerine, Decyl Glucoside, Disodium EDTA, Cocoamidopropyl Betaine, Phenoxyethanol, Sodium Hydroxide, Ethylhexylglycerin.
